#### **Files**

- All registered types of intellectual property rights (e.g. patents, trademarks, utility models, designs, domains, etc.) are included in the standard scope of delivery.
- Other types of files (e.g. contracts, dispute files, search files, expertise files) are supplied as a template for your own versions.
- All types of files are fully amenable and modifiable.
- There is no limit on the number of types of files.
- Several variants of the same types of files can exist side by side (e.g. cooperation agreements, licence agreements, confidentiality agreements, and much more).
- Files can have any relation to each other (e.g. inventions => resulting in property rights => for which contracts are to be concluded => from which licence payments result => to be paid for the inventor's fee)> > >
- Files can contain any meta-information (e.g. own classifications, relevant products, relevant technologies).
- File content can be synchronised with many public data sources (e.g. patents with the EPO (OPS)).

- Automatic assignment of e-mails to files based on recognised file numbers (with \*ADMS).
